ENTERTAINMENT REGULATIONS & WAIVER OF RESPONSIBILITY

For good and valuable consideration, including permission for the signer to participate in the SWFL PRIDE Festival and/or related activities to be held Saturday, October 6, 2018, I, the signer for myself and my group, including all successors, assigns, guardians, heirs, administrators & personal representatives:

1. By signing this agreement you signify that you agree to comply with all terms of this agreement.
2. Each act will be allowed to use a table (provided by SWFL PRIDE committee) to sell CD's, shirts, etc., during their time on stage, and for 30 minutes after the conclusion of their performance. If an entertainer decides to offer something to sell, these items must be approved by Pride-SWFL in advance. Material deemed offensive by Pride-SWFL will not be permitted to be sold or displayed. Any vendor refusing to remove such material may be requested to leave. The table must be manned by a representative of the entertainer. A tip jars will be provided for use on stage.
3. All scheduled entertainment slots will be assigned. Acts are required to sign in *30 minutes* before their scheduled performance time. Failure to adhere to assignments could result in forfeiture of participation in future events and entertainer may be requested to leave.
4. Extremely loud music, amplified voices, squawk boxes, or any other type of sound amplification that would interfere with the surrounding tenants is NOT PERMITTED. This is a family event and all entertainment should be suitable as such.
5. Agree that prior to participating at the SWFL PRIDE Festival, I will inspect the facilities and equipment to be used, and if I believe any of them to be unsafe, I will immediately advise the appropriate event supervisor.
6. Acknowledge that I fully understand that I will be engaging in activities that involve risk of serious injury or death, including economic losses, which might result not only from my own actions, inactions or negligence, but also of others, condition of the facilities or equipment, rules of play or use of this type of equipment or activity.
7. Assume any and all risks of personal injuries to my group and myself. Including but not limited to: medical bills, hospital bills, permanent disability, partial disability, and death and damages to my property, real or personal, caused by or arising from my participation in the event or activity.
8. Agree to indemnify, defend and hold harmless the City of Fort Myers, Lee County, and Pride-SWFL, their officers, directors and volunteers of and from any costs, expenses, claims, damages, suits and liability whatsoever arising from the actions or alleged actions of you, your organization, or your members.
9. I understand that Pride-SWFL is a non-profit organization and SWFL PRIDE is a not-for-profit event. Pride-SWFL does not offer compensation for performance, including travel and associated fees, transportation, accommodations, meals and other performance riders. By submitting this application, I waive my typical performance fee and understands that my performance and preparation may be at my own personal cost.
10. I understand that by submitting this application, I am indicating I am available to play on the dates of the event indicated on this application. The event will be held rain or shine.
11. I understand that selected entertainers at SWFL Pride are ambassadors of the organization throughout the SWFL Pride festival and I acknowledge I am willing and able to help promote and publicize the event and my performance through my own social media networks and publicity connections.
12. I understand that if selected to perform I must abide by all policies of Pride-SWFL outlines in the formal artist engagement agreement
13. I understand that all submitted materials becomes the property of Pride-SWFL and will not be returned.
